2021-2 Exchange Student program

- ✓ Those who have been officially nominated by partner institutions were asked to complete the online application (enter.mju.ac.kr) 2021 May
- ✓ Issuance of official letter of admission after the application review : 2021 May~July
- ✓ Communication to partner institutions about changing Korean government policy pertaining to COVID-19, especially those regarding entry visa
- ✓ Offered the postponement of admission for those who were not able to enter Korea before August 22
- ✓ Self-quarantine monitoting for the first 14 days upon students' arrival
- Daily monitoring of temperature check (Via SNS, such as LINE)
- The official course registration was done by the OIA baed on students' Korean and/or English language proficiency during students' guarantine period.
- Students from the International Student Outreach Club(Oulami) were assigned to International exchange students (ratio of 1 Korean student to 4~5 International students) to assist them with course add/drop as well as applying for the alien registration card.

What precautionary measures are in place in your country and in your institution?

- ✓ Mask required for all persons working/studying on campus
- ✓ Regular disinfection of frequently touched areas by staff and faculty in each department/office.
- ✓ Daily disinfection/cleaning of all buildings and facilities on campus: Campus buildings are being cleaned up more frequently with a special emphasis on cleaning areas such as flat surfaces,bathrooms, door knobs, elevators, and areas of high-traffic and high-touch activity.
- ✓ Monitoring of all arriving students, including daily temperature monitoring during the 14-daysquarantine
- ✓ For faculty/staff working on campus: After a quick temperature check, employees without a fever received a colored "dot of the day" sticker for their badge to show they have been screened.(now changed to an online "check-in" system after daily temperature check at each buildingentrance).
- ✓ For 2021 fall semester, all international exchange students (both new and returning) were required to arrive in Korea by August 22 to make sure every one of them has spent at least 14days of self-quarantine period till the first week of the semester. Physical presence was required to maintain their student visa status in accordance with immigration law. We decided to cancel admission of exchange students who arrive in Korea after August 22 as such students will not be able to satisfythe 14-days self-quarantine period.
- ✓ We will continue to monitor the severity of the outbreak and the impact on our student community. The health and well-being of the community is our first priority, so if we reach a point where students cannot safely physically attend classes, course expectations would be adjusted accordingly.
- ✓ Our Exchange students who are currently in Korea are strongly discouraged from traveling away from Korea at this time. Travelers may experience restrictions or cancellations concerning theirtravel arrangements without warning, in addition to the risk of being unable to return to their original program location. If they have to travel to a medical emergency in their immediate family, they are required to have their parents/legal guardian write an email to us, acknowledging that it is their own responsibility to take care of their safety and well-being and to be informed about all the countries they are visiting (this includes understanding any risks, and planning for their safety). It's also their responsibility to stay informed, in case things change.

Is a quarantine mandatory upon arrival, if yes how long?

- ✓ Yes, as of today(September 21), 2 weeks quarantine upon arrival is arrived.(i.e. For travelers who arrive on June 1, the quarantine ends at noon on June 15.
- ✓ Travelers who received all vaccine doses in their home countries generally still undergo 14 days of quarantine at their own expense.
- ✓ Some exceptions may apply:
- Travelers fully vaccinated in Korea and whose vaccinations are registered in the Korean health care system may be eligible for monitoring in lieu of quarantine at the discretion of Korean authorities at the point of entry.

- Travelers who received the 1st dose of a two-dose vaccine in Korea and the 2nd dose of the vaccine in the United States may be eligible for monitoring in lieu of quarantine if the 2nd dose is registered in the Korean health care system.

Do travelers need to pass a covid-19 test or present a document stating that they are covid-19 negative upon their arrival?

Effective 12:00 a.m. on January 8, 2021, all foreign passengers arriving in the Republic of Korea (ROK)must provide proof of a negative COVID-19 PCR test obtained within 72 hours of their departure. Airlines will not board passengers without a negative PCR test result issued within 72 hours. Arrivingpassengers must submit the PCR test result on an original form issued by the testing center in the country of origin (in the English or Korean language) to quarantine authorities. Authorities will deny entry to individuals who do not fulfill this requirement.

Is public transportation reliable at this time?

Masks are compulsory on all modes of public transportation, including taxis and domestic/internationalflights. Drivers and pilots are authorized to deny passengers who refuse to wear a mask.

Are restaurants open?

- ✓ Under the renewed plan that will be effective from Monday to Oct. 3, the greater Seoul area will remain under the toughest Level 4 social distancing, while the rest of the country will be under Level 3, The government partly relieved the current 9 p.m. curfew on cafes and restaurants in the capital area, allowing them to open till 10 p.m. during the next month.
- ✓ Under the new social distancing scheme, a social gathering of up to six people will be allowed in the capital area before 6 p.m. if two of them are fully vaccinated. Currently, a social gathering of up to four people is possible in areas under Level 4 distancing after 6 p.m. if two of them are fully vaccinated.

Does your country require a vaccine passport?
